CIT Training at GOC

Members of local law enforcement came to the Gainesville Opportunity Center the second week in April for CIT Training. A Crisis Intervention Team (CIT) program is a model for policing that bring law enforcement and mental health care providers together to better help individual with mental illness and to improve police response to people in crisis.

During Crisis Intervention Training local law enforcement officers learn about people with mental health issues and how they can better interact with members of the community with mental health challenges. It was nice seeing them here trying to learn more about how to work with people with mental illness.

The Baker Act affects people with mental illness, and I have had to go through it myself. It is a hard situation for the police to know what to do with someone with mental illness, especially when people are in crisis. For the police to be educated about how to handle situations or at least to de-escalate or calm situations down to prevent bad things from occurring is a proactive way that law enforcement can help our members. I am glad that they have this training for police officers and hope that good will come from this training.

I like the police, and am glad that we can help make their jobs easier. At the same time this program is helping people with mental illness discover what is the best solutions when law enforcement is involved. Hopefully more people can be informed and mental health and how we can work smoothly together!

If we can all work together to help law enforcement gain knowledge about people with mental illness, we can all help each other. Sharing our experiences with each other and what we have learned about interacting with law enforcement is helpful. Perhaps you can participate in our next CIT training which we have every three months.

Secretary Carroll and Bryant both agreed that Clubhouses are very important to the mental health recovery process. They recognize that giving people low-cost support helps keep them out of crisis and helps keep them employed.


This year, Secretary Carroll was awarded an extra seven hundred thousand dollars for mental health Clubhouses to use for supported employment programs. Our director, Brett, was meeting with them to ask for our share of the revenue.

Many times mental health gets criminalized and the Public Defender was interested in visiting a mental health clubhouse to see what how the GOC benefits our Members. Ms. Scott listened to several members about how mental illness has impacted their lives, and voiced her commitment to treating with people living with mental illness with dignity, respect and non-violence.

Visit to Vincent House

On April 4 Executive Director Brett Buell, GOC Board President Cyndi Garvan, and Vice President Trish Sokol visited Vincent House, the mental health clubhouse in Pinellas Park. Vincent House has long been a model clubhouse and is emulated by other entities that follow the International Clubhouse Model.

The purpose of the visit was to attend their Findings meeting for International Clubhouse Accreditation. For full Accreditation, a Clubhouse has to adhere to a strict model and perform certain tasks. We wanted to hear how those tasks standards were graded as we work towards full accreditation.

The GOC follows the Clubhouse Model of recovery through work. We are contracted with the State of Florida for Mental Health Clubhouse Services. We provide nearly every program required for full accreditation. Due to our funding level, we are limited in staff size and cannot offer Transitional Employment. The "TE" program requires staff to work off site with members, and we lack the funding for that staff position.
