A WORD FROM THE EXECUTIVE DIRECTOR

In 2023, the GOC found one thing to be sure - we would experience change! The changes required copious amounts of patience and effort to accomplish our goals of improving how we serve persons with mental illness and spreading awareness of the importance of Clubhouses. Collectively, the GOC members, employees, board, and community partners embraced the changes, and together, we accomplished the following:

- Served 102 individuals with severe and persistent mental illness through the Work-Ordered-Day program (WOD), which engages members to work side-by-side with staff to run the Clubhouse.
- In addition to the WOD program, GOC employees provided 1,570 in-depth support services to empower members to pursue personal goals of independence, education, transportation, wellness, and social activities.
- Nearly 20% of these support services focused on member employment readiness and obtaining or maintaining work.
- With support from the Rotary Club Foundation of Gainesville, we completely renovated the kitchen and dining room to improve the quality of our food and dining services to Clubhouse Members, staff, and guests.
- The GOC hosted the 3rd Florida Clubhouse Coalition Summit, a two-day conference welcoming all nineteen Florida Clubhouses, including keynote speakers and guests from accredited Florida Clubhouses, Florida Association of Managing Entities (FAME), LSF, International Clubhouse Coalition, and our partners from the City of Gainesville.

The dedication of our members, employees, board, volunteers, and partners made this year a success! Thank you to everyone for helping us navigate continuous change and improvement in how we serve and soar to greater heights!




